OUR IMPACT

HELPING PEOPLE. CHANGING LIVES.

We work with leaders in Orange County to help us identify problems and find solutions so that we can invest your money where people need it the most.

In our community, and for many, earnings from a full-time minimum wage job fail to provide a sufficient income to lift a family out of poverty. We provide workshops that help clients develop financial literacy skills to make better use of their limited resources.

CAPOC partners with organizations to create and save jobs so that struggling families can afford to pay their bills.

Our Family Resource Centers provide English as a Second Language and High School GED classes to decrease high school drop out rates.

Our OC Food Bank works to support the lives of the 1 in 5 Orange County children living in poverty by providing them with nutrition and supplemental food programs to ensure that they will not go hungry or become malnourished.

Orange County's low-income communities have concerns including high unemployment, failing schools, inadequate housing, poor health, and crime. We work to provide support and training to local residents so they can become the primary agents of change in their community and tackle our most complex issues.

OUR PROJECTS

We have a variety of strategies and approaches that get results. We can work with you and your budget to make your donation fit the program area or service you wish to support.

By donating to Community Action Partnership of Orange County, you can help us provide services that our contracts can't cover. Here are just a few examples of the services your donation can support:

A \$500 donation can buy 50 food boxes and provide Orange County families with 1,400 meals.

A \$1,000 donation can install energy and water conservation measures to help families save money that could be used to meet other basic needs.

A \$1,500 donation can help offset the costs of building wheelchair ramps or widening the doors of neighbors with disabilities.

A \$2,000 donation can provide one year of bus passes to one of our Family Resource Centers.

A \$2,500 donation can provide 100 families support during a Case Management Project.

A **\$4,000** donation can sponsor two neighborhood clean-ups.

A \$5,000 donation can pay for the start-up costs of a Community Garden.

A **\$12,500** donation can provide 5 families matching funds for Individual Development Accounts.

A \$25,000 donation can provide the staff and supplies for our Summer Youth Program with an emphasis on science, math, technology, and the arts.

A \$50,000 donation can provide fresh fruits and vegetables to 400 families every week for a year.
